## ***Purpose***

## ***Membership***

INHAA is the only association in Illinois designed specifically for the benefit of the administrator. Yearly memberships are \$100, beginning on January 1 and ending on December 31.

## ***Meetings and Seminars***

Educational seminars, the heart of the Association for both administrators and nurses, are held quarterly. The Annual Convention, with a vendor trade show, is held in the fall.

The Illinois Nursing Home Administrator's Association is an approved "Continuing Education Sponsor" with the Illinois Department of Financial and Professional Regulation for administrators and nurses.
