Your facility is required to use the QAPI process including Root Cause Analysis during investigations. Providers must not only find the cause of the incident, but also determine how to avoid future incidents.

Many providers still do not understand this important process. This course will review the requirements of QAPI and its importance since surveyors are asking for your QAPI Program and the Root Cause Analysis reports.
