*On October 1, 2019, the SNF world was changed by the implementation of a new billing system, PDPM. The change from RUGs to PDPM was extensive, with patient characteristics becoming the basis for payment. This session will focus on where we are 6 months later. Are our SNFs better off? Are we able to identify pertinent patient characteristics? Is the system less burdensome? What are PDPM best practices? What aspects of PDPM are still challenging?*

**Sexual Harassment Training (Now Required by IDFPR)**

**Presented by Jennifer Long, Special Counsel, Duane Morris LLP**

*A new law passed earlier this year that requires sexual harassment prevention training for all persons who hold a professional license issued by the Division of Professional Regulation for professions that require CE to renew. The law requires licensees to complete a one-hour CE course in sexual harassment prevention training and was effective for all renewals on or after January 1, 2020. This CE requirement is included in the number of hours already required under the individual Acts and Rules and does not increase the number of hours required to renew a license. This session will satisfy the training elements in Illinois law under the Illinois Human Rights Act, 775 ILCS 5/2-109. The training will include information and practical guidance regarding state and federal harassment laws, practical examples about how to prevent harassment and discrimination, and how to appropriately report those situations.*
